News from Public Works Board, Water Policy Board, and Municipal Wastewater Committee Meetings

- For the remainder of 2013, the Public Works Board meeting time will be changed to 4:00 PM to coincide with the rest of the Boards' meetings.
- The punch list items have been completed on the Hall of Justice first floor remodel. Testing and balancing of the HVAC system is being conducted throughout the building now that remodeling projects are finished.
- The water tank at Michigan's Adventure will receive a 5-year inspection, as approved by the Board. The Whitehall Road line will also be flushed soon to maintain adequate chlorine levels.
- MDEQ is very pleased with MCWMS for having zero violations on their 2012 National Pollutant Discharge Elimination System (NPDES) permit!
- The Board approved the purchase of GPS equipment to be installed on the compactor and dozer in the Solid Waste Department and the excavator in the Wastewater Department. This technology will be shared between the departments and will improve accuracy and efficiency.
- The bid was awarded to complete the rehab of the Ruddiman sewer line, with work starting in May and being completed late this summer.
- The Sewer Use Ordinance and the new local limits for industrial dischargers has gone through the necessary steps and notices and was approved by the Public Works Board. The new ordinance will go into effect April 1.
- Ducks Unlimited will be hosting an open house and ceremonial groundbreaking for the Black Creek Filter Marsh on Tuesday, April 9, at 10 AM near the Operations Maintenance building, 9065 E. Laketon Avenue, on the Wastewater site.
- The Parks are offering **FREE County Parks Day** on **Saturday**, **May 4**, **from 10 AM 4 PM at Twin Lake and Pioneer Parks**. In addition to free admission, there will be free workshops offered with fun for the entire family! Food and refreshments will be available.
