VISITOR PASS – TERMS AND CONDITIONS

1) AUTHORITY

- a) Visitor Passes are issued at the Administration Building or online at the address above, by Recovery Center personnel on Monday-Friday, 8:00 am to 4:45 pm, with the exception of Holidays. A pass is required for any and all activities on the premises and is valid from **Dawn to Dusk**.
- b) Day Passes are issued for the day. Day passes can be issued for the weekend and are usually issued on the Friday before.
- c) Annual Passes are issued or rejected based on review by the Safety Coordinator. Annual passes are not issued for Scouting in advance of hunting.
- d) **Visitors are not permitted in restricted areas. Please watch for newly placed restricted area signage.**
- e) Resource Recovery Center currently has contracts for site access with:

2) PERMISSIBLE ACTIVITIES INCLUDE:

- a) Bird Watching
- b) Hiking
- c) Photography
- d) Group Activities as above
- e) Wildlife Observation
- f) Bike Riding
- g) Cross Country Ski or Snowshoe (Established Trails Only)
- h) Hunting/Trapping (With Appropriate Separate Recovery Center Permit)

3) PROHIBITED:

- a) **Motorized Recreational Vehicles**
- b) **Unleashed Pets**
- c) **Feeding or Spooking Wildlife**
- d) **Littering**
- e) **Sledding**
- f) **Entry by any means to the Center Dike during gull nesting**

4) SAFETY/RESPONSIBILITIES

- a) **All visits are at your own risk**
- b) **Please refrain from interruption of Recovery Center site activities/operations**
- c) **Drive carefully & responsibly- DO NOT Block Roadways**
- d) **Adhere to posted regulations**
- e) **Seasonal roads are not plowed**
- f) **Remain on established roads**
- g) **If your vehicle becomes stuck, you are responsible for arranging assistance. Resource Recovery cannot use County personnel or equipment for retrieval**

5) DISPUTES/DISTURBANCES

- a) Any Visitor that witnesses or is a part of an issue/concern while on the site, we ask that you stop by the Administration Building to document the event.

6) REVOCATION

- a) Any site use that is deemed by Resource Recovery or law enforcement staff as illegal, unsafe, disruptive or in violation of the Terms and Conditions, may result in revocation of the visitor pass, prosecution or both.

7) ACCEPTANCE
